AN ORDINANCE TO CORRECT THE ROAD & DRAINAGE INVENTORY TO INCLUDE RIVER ROAD LATERAL; DIXIE RANCH ROAD LATERAL; HERMAN SINGLETARY ROAD LATERAL; BUCK RUN LATERAL; 5TH STREET; AND SOUTH STREET. WARDS 3, 4, 6 & 9, DISTRICTS 2, 5, 6, 9 & 11

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Include River Road Lateral (D03HW03001) approximately 500 feet, located south on River Road (R03H001) 300 feet from Autumn Drive; Ward 3, District 2;
2. Include Dixie Ranch Road Lateral (D09CW03033), approximately 830 feet, located north east off Dixie Ranch Road (R09C033) at station 11+65 past Fenner Road, Ward 9, District 11; and
3. Include Herman Singletary Road Lateral (D06IW02015), approximately 800 feet, located north off Herman Singletary Road (R06I015), Ward 6, District 6; and
4. Include Buck Run Lateral (D09IW01039), approximately 2,100 feet, located south of Buck Run (R09I039); and
5. Include 5th Street, approximately 285 feet, located north off Lasalle Street (R04D059), Ward 4, District 5; and
6. Include South Street, approximately 550 feet, located west of Fourth Avenue (R03L008), Ward 3, District 5;

BE IT FURTHER ORDAINED, that the Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
