RESOLUTION TO ACKNOWLEDGE THE AUTHORITY PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 3-01 AND 3-09 FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A MEMORANDUM OF UNDERSTANDING WITH PROGRESSIVE WASTE SOLUTIONS OF LA, INC. FOR BILL COLLECTION SERVICES.

WHEREAS, St. Tammany Parish, through Tammany Utilities, provides potable water and sewage collection and treatment services to residents of St. Tammany Parish; and

WHEREAS, Progressive Waste Solutions of LA, Inc. and/or its affiliates ("Progressive") provides garbage collection and disposal services to residents of St. Tammany Parish; and

WHEREAS, Progressive desires that Tammany Utilities provide bill collection services for those Parish residents receiving both Tammany Utilities' and Progressive's services.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish of St. Tammany, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 3-01 and 3-09, is authorized to enter into a Memorandum of Understanding, which meets or exceeds all of the requirements of Louisiana law and jurisprudence, with Progressive Waste Solutions of LA, Inc. and/or its affiliates for bill collection services and to take any and all actions necessary in support of same.

RESOLUTION TO ACKNOWLEDGE THE AUTHORITY PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 3-01 AND 3-09 FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE TCHEFUNCTE RIVER FOUNDATION, INC. FOR OPERATION AND IMPROVEMENTS TO NORTHSORE BEACH (WARD 9, DISTRICT 13).

Parish seeks to enter into a Memorandum of Understanding with Progressive Waste Solutions of LA, Inc. and/or its affiliates for bill collection services. Tammany Utilities will bill Progressive's garbage collection services to its customers also receiving Progressive's services and remit the garbage collection service charges to Progressive, less a \$2.00 administrative fee per account.

No Tammany Utilities customer shall be compelled to utilize Progressive.
