403-14	BP - Promotional Tourism Grant	BP Settlement Trust - In an effort to increase tourism in the area, St. Tammany Parish will develop a marketing plan to include a mix of digital and print media to brand the Parish as a destination for long and relaxing weekend retreats.
425-02	CSBG	Louisiana Workforce Commission - decrease in grant funding due to sequestration.
425-13	LIHEAP PY 2013	La. Association of Community Action Partnerships - increase in funding to provide energy assistance to low income families.
425-37	Cleco Care	Cleco - to provide 25% discount on fuel portion of customers bill for approved low income families.
425-48	Weatherization - ARRA 2nd allocation	LACAP, Inc. - to reduce energy bills of low income families by providing home repairs that can help in making the home more energy efficient.
