

Legal Description of a 60 Ft. Right of Way (1.1120 Acres)

A certain parcel of land situated in Section 44, Township 9 South, Range 14 East, Greensburg Land District, St. Tammany Parish, Louisiana and more fully described as follows.

Commence at the Section corner common to Sections 26 and 44, Township 9 South, Range 14 East and measure South 67 degrees 37 minutes 30 seconds West a distance of 659.98 fee to a point; Thence North 40 degrees 27 minutes 50 seconds West a distance of 204.58 feet to a point; Thence South 67 degrees 39 minutes 30 seconds West a distance of 659.38 feet to a point; Thence South 40 degrees 25 minutes 40 seconds East a distance of 1,147.21 feet to a point; Thence South 71 degrees 33 minutes 00 seconds West a distance of 2,724.27 feet to a point; Thence North 26 degrees 36 minutes 04 seconds East a distance of 586.60 feet to a point; Thence South 61 degrees 44 minutes 21 seconds East a distance of 32.00 feet to a point; Thence North 27 degrees 39 minutes 50 seconds West a distance of 427.46 feet to a point; Thence North 61 degrees 48 minutes 41 seconds West a distance of 6.59 feet to a point; Thence North 15 degrees 39 minutes 06 seconds West a distance of 269.11 feet to the POINT OF BEGINNING.

From the POINT OF BEGINNING measure

South 28 degrees 02 minutes 49 seconds West a distance of 5.77 feet to a point; Thence North 61 degrees 44 minutes 21 seconds West a distance of 806.34 feet to a point; Thence North 26 degrees 14 minutes 07 seconds East a distance of 60.04 feet to a point; Thence South 61 degrees 44 minutes 21 seconds East a distance of 808.24 feet to a point; Thence South 28 degrees 02 minutes 49 seconds West a distance of 54.23 feet to a point which is the POINT OF BEGINNING, and containing 48,437.58 square feet or 1.1120 acre(s) of land, more or less.
