


Ordinance Administrative Comment

ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACQUIRE CERTAIN PARCELS OF LAND AND/OR SERVITUDES, FOR THE ST. TAMMANY REGIONAL AIRPORT PROJECT (WARD 4, DISTRICT 7).

St. Tammany Parish seeks to acquire, certain parcels of land and/or servitudes west of the St. Tammany Regional Airport to remove tree obstruction. The Parish intends to pay no more than appraised value or less, plus costs and fees.
