AN ORDINANCE TO CORRECT THE ROAD & DRAINAGE INVENTORY TO INCLUDE MILTON CRADDOCK ROAD LATERAL; PHEASANT LANE LATERAL; HIGHWAY 190 LATERAL; HARRISON AVENUE POND; RIVERSIDE DRIVE LATERAL; HOUSE ROAD LATERAL, AND RAPATEL STREET . WARDS 3, 4 & 6, DISTRICTS 2, 3, 5, 6 & 7

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Milton Craddock Road Lateral (#D06EW01021), approximately 250 feet, located east from Milton Craddock Road (R06E021), Ward 6, District 6;
2. Add Pheasant Lane Lateral (#D03HW01004), approximately 1,400 feet, located north from Pheasant Lane (R03H004), Ward 3, District 2;
3. Add Highway 190 Lateral (#DHL190W001), approximately 2,240 feet, located south from Highway 190 (HL190), Ward 3, District 3;
4. Add Harrison Avenue Pond (#P03LW01034), located south of Harrison Avenue (R03L034) and bounded by Webster Avenue, 6th Street, Harrison Avenue and 10th Street; Ward 3, District 5;
5. Add Riverside Drive Lateral (#D03BW02002), approximately 270 feet, located northwest from Riverside Drive (R03B002), Ward 3, District 5;
6. Add House Road Lateral (#D03IW01005), approximately 285 feet, located east from the intersection of House Road (R03I005) and Epsilon Avenue, Ward 3, District 2; and
7. Add Rapatel Street (R04E325), approximately 300 feet, located north off Joans Street (R04E056).

BE IT FURTHER ORDAINED, that the Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
