ORDINANCE TO EXTEND FOR SIX (6) MONTHS THE MORATORIUM ON THE ISSUANCE OF PERMITS FOR CONSTRUCTION OR PLACEMENT OF NON-SINGLE FAMILY RESIDENTIAL BUILDING STRUCTURES ON PROPERTY WITHIN A PORTION OF VOTING PRECINCT 310, NORTH OF ABITA RIVER. (DISTRICT 5)

WHEREAS, the Parish Council adopted Ordinance C.S. No. 14-3114 initiating the six (6) month building moratorium within a portion of Voting Precinct 310, north of Abita River; and

WHEREAS, the moratorium was created to protect and preserve the health, safety and property interests of residents from the adverse conditions due to road construction and closures; and

WHEREAS, it is necessary to further extend the moratorium to allow sufficient time for evaluation of present traffic conditions affecting the area and remedies therein to protect residents in and near the area more fully described within this ordinance.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that it imposes a six (6) month moratorium on the issuance of permits for construction or placement of non-single family residential building structures on property within a portion of Voting Precinct 310, north of Abita River in District 5.

BE IT FURTHER ORDAINED that this Ordinance shall be effective immediately upon final adoption and remain in effect through April 2, 2015

BE IT FURTHER ORDAINED that the moratorium imposed may be vacated, in whole or in part, by Resolution of this governing body pursuant to Chapter 5, Article II, Section 5-0556.00 of the Parish Code of Ordinances.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon final adoption.
