RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER, SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE JUSTICES OF THE PEACE OF ST. TAMMANY PARISH FOR USE OF SPACE IN THE PARISH ADMINISTRATIVE COMPLEX FOR HOLDING OF LITTER COURT.

WHEREAS, Parish recognizes that effective litter control and enforcement protects the public health, safety and welfare; prevents land, water and air pollution; prevents the spread of diseases and the creation of nuisances; conserves natural resources; and enhances the beauty and quality of the environment; and

WHEREAS, the St. Tammany Parish Justices of the Peace form a vital link in litter control and enforcement, and the Parish maintains resources that can benefit the Justices in their pursuit of litter control and enforcement; and

WHEREAS, the Justices of the Peace desire usage of the Council Chambers for the holding of Litter Court hearings.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish of St. Tammany, through the Office of the Parish President, pursuant to Home Rule Charter Sections 1-04, 1-06, 3-01 and 3-09, is authorized to enter into a Cooperative Endeavor Agreement, which meets or exceeds all of the requirements of Louisiana law and jurisprudence, with one or more Justices of the Peace of St. Tammany Parish for the use of Council Chambers for Litter Court hearings and to take any and all actions necessary in support of same.

Resolution Administrative Comment

RESOLUTION TO acknowledge the authority, pursuant to Home Rule Charter, Sections 1-04, 1-06, 3-01 and 3-09, for the Parish of St. Tammany, through the Office of the Parish President, to execute a Cooperative Endeavor Agreement with the Justices of the Peace of St. Tammany Parish for use of space in the Parish Administrative Complex for holding of Litter Court.

St. Tammany Parish Government is seeking to enter into a Cooperative Endeavor Agreement with one (1) or more Justices of the Peace willing to participate with litter enforcement. Parish will rotate the availability of the Council Chambers as necessary and as available. In exchange for the use of the Council Chambers, Justices will enforce Parish's litter laws through the Justice of the Peace's litter courts.
