ORDINANCE TO DECLARE LOT 2, SQUARE C, LAKESHORE VILLAGE SUBDIVISION (3714 RIVIERA DRIVE, SLIDELL) AS SURPLUS TAX-ADJUDICTED PROPERTY AND AUTHORIZE THE DONATION OF SAID PROPERTY TO THE CITY OF SLIDELL (WARD 9, DISTRICT 12).

WHEREAS, the Parish of St. Tammany owns an adjudicated tax deed to property described as Lot 2, Square C, Lakeshore Village Subdivision or 3714 Riviera Drive, Slidell (the "Property"), said property having been adjudicated to St. Tammany Parish for unpaid property taxes; and

WHEREAS, the City of Slidell has identified the Property as blighted and the neighboring properties are endangered by the hazardous, unmaintained condition of the Property; and

WHEREAS, Parish desires to donate the Property to the City of Slidell for Slidell's use in allievating the blighted condition of the property in accordance with the disposition of adjudicated property procedures provided by Louisiana Revised Statutes Section 47:2196, et seq. and also as authorized by Louisiana Revised Statutes Section 47:2205 and Louisiana Revised Statutes Section 33:1321, et seq.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the Parish Council declares the tax-adjudicated Lot 2, Square C, Lakeshore Village Subdivision as surplus property and authorizes the donation to the City of Slidell in accordance with the disposition of adjudicated proeprty procedures provided by Louisiana Revised Stutes Section 47:2196, et seq.

BE IT FURTHER ORDAINED that the Parish President is authorized to sign any and all documents necessary to effectuate the donation to the City of Slidell.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
