ORDINANCE ESTABLISHING A NO THRU TRUCKS ZONE ON BREWSTER ROAD, BETWEEN LOUISIANA HIGHWAY 1077 AND LOUISIANA HIGHWAY 1085. WARD 1, DISTRICT 1

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the Parish; and

WHEREAS, St. Tammany Parish has experienced an increase in truck traffic through a primarily residential neighborhood; and

WHEREAS, the affected citizens have requested a no thru truck zone to remedy the situation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: A "NO THRU TRUCKS" ZONE is hereby established on Brewster Road (R01J012) between Louisiana Highway 1077 and Louisiana Highway 1085, as indicated on the attached traffic plan by the Department of Engineering. WARD 1, DISTRICT 1.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at these locations.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

The Department of Engineering recommends the installation of Signage to be installed in District 1.

1. Raise and Replace DOUBLE LARGE ARROW sign at the intersection of Hwy 1085 and Brewster.
2. Install NO THRU TRUCK sign on Brewster, 50' from the Brewster and Hwy 1085 intersection.
3. Raise and Replace SPEED LIMIT 35 sign on Brewster near the Hwy 1085 intersection.
4. Remove Slow Children @ Play sign from 35 mph zone on Brewster near Oak Park.
5. Raise and Replace STOP AHEAD sign on Brewster, near the Brewster and Perrilloux intersection.
6. Install SPEED LIMIT 35 sign across from Job #5 facing oncoming traffic.
7. Raise and Replace ALL 4 STOP signs at the Perrilloux and Brewster intersection and Add ALL-WAY Plaques to each stop sign.
8. Replace DO NOT PASS sign on Brewster near the Perrilloux intersection.
9. Raise and Replace STOP AHEAD sign on Brewster, near the Brewster and Perrilloux intersection.
10. Install SPEED LIMIT 35 sign on Brewster, 200' from the Dummy Line and Brewster intersection.
11. Install SPEED LIMIT 35 sign on Brewster, 200' from the Dummy Line and Brewster intersection.
12. Install NO THRU TRUCK sign on Brewster, 50' from the Brewster and Hwy 1077 intersection.
