AN ORDINANCE TO CORRECT THE ROAD & DRAINAGE INVENTORY TO INCLUDE ROBERT BUSH ROAD LATERAL; WATTS THOMAS ROAD LATERAL; OAK KNOLL ROAD LATERAL AND AN EXTENSION OF THIRD AVENUE. WARDS 3, 5, 6 & 10, DISTRICTS 5 & 6

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Include Robert Bush Road Lateral (D10CW01017), approximately 770 feet, located south of Lowe Davis Road, Ward 10, District 6; and
2. Include Watts Thomas Road Lateral (D05EW04022), approximately 1,300 feet, located south off LA Highway 41, Ward 5, District 6; and
3. Include Oak Knoll Road Lateral (D06OW01032), approximately 1,600 feet, located south southwest off Peg Keller Road , Ward 6, District 6; and
4. Include an approximately 388 feet extension of Third Avenue (R03L007) to the existing length of 3069, bringing the total length maintained to 3,457 feet, located northwest off Helenbirg Road, Ward 3, District 5.

BE IT FURTHER ORDAINED, that the Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
