RESOLUTION TO ACKNOWLEDGE THE AUTHORITY PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09 FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE ST. TAMMANY PARISH SHERIFF’S OFFICE FOR THE PURPOSE OF PROVIDING SECURITY TO THE KOOP DRIVE ADMINISTRATIVE COMPLEX.

WHEREAS, St. Tammany Parish and the St. Tammany Parish Sheriff’s Office recognize their obligations to provide for the protection of public health, safety and welfare afforded the citizens of St. Tammany Parish in their joint pursuit to ensure the safety of employees, patrons and the general public while on the grounds of the Parish’s Koop Drive Administrative Complex and associated buildings; and

WHEREAS, St. Tammany Parish Sheriff’s Office is capable of and desires to provide security at the Koop Drive Administrative Complex. Further, having the St. Tammany Parish Sheriff’s Office provide security at the Koop Drive Administrative Complex maintains a law enforcement presence which is an added benefit to the Parish in fulfilling its obligation to provide security; and

WHEREAS, St. Tammany Parish desires to enter into a Cooperative Endeavor Agreement which the St. Tammany Parish Sheriff for the provision of security at the Koop Drive Administrative Complex which will more specifically state each parties’ obligations.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish of St. Tammany, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 1-06, 3-01 and 3-09 is authorized to enter into a Cooperative Endeavor Agreement, which meets or exceeds all of the requirements of Louisiana law and jurisprudence, with the St. Tammany Parish Sheriff’s Office for the provision of security at the Koop Drive Administrative Complex and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions authorized herein.

BE IT FURTHER RESOLVED, that all acts previously taken by the Office of the Parish President in furtherance of the actions or agreements contemplated herein are hereby ratified and approved.
