Dorsey, Notary Public, dated August 15, 1978, and according thereto, said lot is situated in SQUARE NO. 10 which is bounded by Belle Terre Boulevard, Lot No. 18, Lot No. 20 and the Northern Boundary of Subdivision, said lot is designated as LOT NO.19, measures 111 feet front on Belle Terre Boulevard, with a width in the rear of 100 feet and a depth on the sideline nearer to Lot No. 18 of 198.6 feet, with a depth on the opposite sideline nearer to Lot No. 20 of 200 feet.

The improvements thereon bear the Municipal No. 158 Belle Terre Boulevard, Covington, Louisiana.
