Mandeville ByPass - La. 1088 to US 190
Parish ID # R04E260

The Mandeville By Pass is an east-west "by pass" east of Mandeville connecting Hwy 1088 and US 190. The corridor is to provide relief and an alternate route for traffic now using La 1088, La 59 and portions of US 190 through the City of Mandeville to reach US 190 east of Mandeville. The two lane roadway would exist within a 200 foot right-of-way with an approximate length of 18,500 feet or 3.5 Miles.
