RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01, AND 3-09, FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH ST. TAMMANY PARISH SUB-DRAINAGE DISTRICT NO. 5 OF GRAVITY DRAINAGE DISTRICT NO. 5 FOR DRAINAGE REPAIRS AND MAINTENANCE.

WHEREAS, it is imperative that the integrity of the Bayou Monga Drainage Basin be repaired, improved and maintained immediately to protect the public; and

WHEREAS, drainage repairs, improvements and maintenance are needed to improve the infrastructure located within St. Tammany Parish Sub-Drainage District No. 5 of Gravity Drainage District No. 5 including Emerald Oaks Subdivision; and

WHEREAS, the said work to be preformed will benefit areas beyond the boundaries of the said Sub-Drainage District.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 1-06, 3-01, and 3-09 is authorized to execute a Cooperative Endeavor Agreement with St. Tammany Parish Sub-Drainage District No. 5 of Gravity Drainage District No. 5, which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the repairs, improvements and maintenance to the identified areas and to take any and all actions necessary, including entering into all agreements or negotiations in furtherance of the actions contemplated herein.

BE IT FURTHER RESOLVED, that all acts previously taken by the Office of the Parish President in furtherance of the actions or agreements contemplated herein are hereby ratified and approved.
