ORDINANCE TO AMEND ST. TAMMANY PARISH CODE OF ORDINANCES, CHAPTER 16, PARKS AND RECREATION. ARTICLE V, RECREATION DISTRICT NO. 4, SEC. 16-051-00 CREATED: BOUNDARIES; GOVERNING BOARD, PROVIDING FOR THE AMENDMENT OF THE BOUNDARIES OF RECREATION DISTRICT N. 4 (WARD7, DISTRICT 7 & 11)

WHEREAS, the St. Tammany Parish Council adopted Ordinance C. S. NO. No. 81-238, adopted 07/23/81, which created Recreation District 4 the boundaries of which shall be the entire Seventh Ward of the Parish as it existed on May 5, 1977; and

WHEREAS, there is now a need to reduce the boundaries of Recreation District No. 4 to exclude that portion which is in Council District 11; and

WHEREAS, attached as Exhibit "A" is a map showing the adjusted boundaries of Recreation District No. 4 as amended herein.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the boundaries of Recreation District No. 4 are hereby amended to exclude St. Tammany Parish Council District 11.

BE IT FURTHER ORDAINED that Section 16-051-00 of the Parish Code of Ordinance be amended as follows:

There is hereby created St. Tammany Parish Recreation District No. 4, the boundaries of which shall be the entire Seventh Ward of the Parish as it existed on May 5, 1977, excluding that portion included in the boundaries of Council District 11 as they exist on August 6, 2015.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

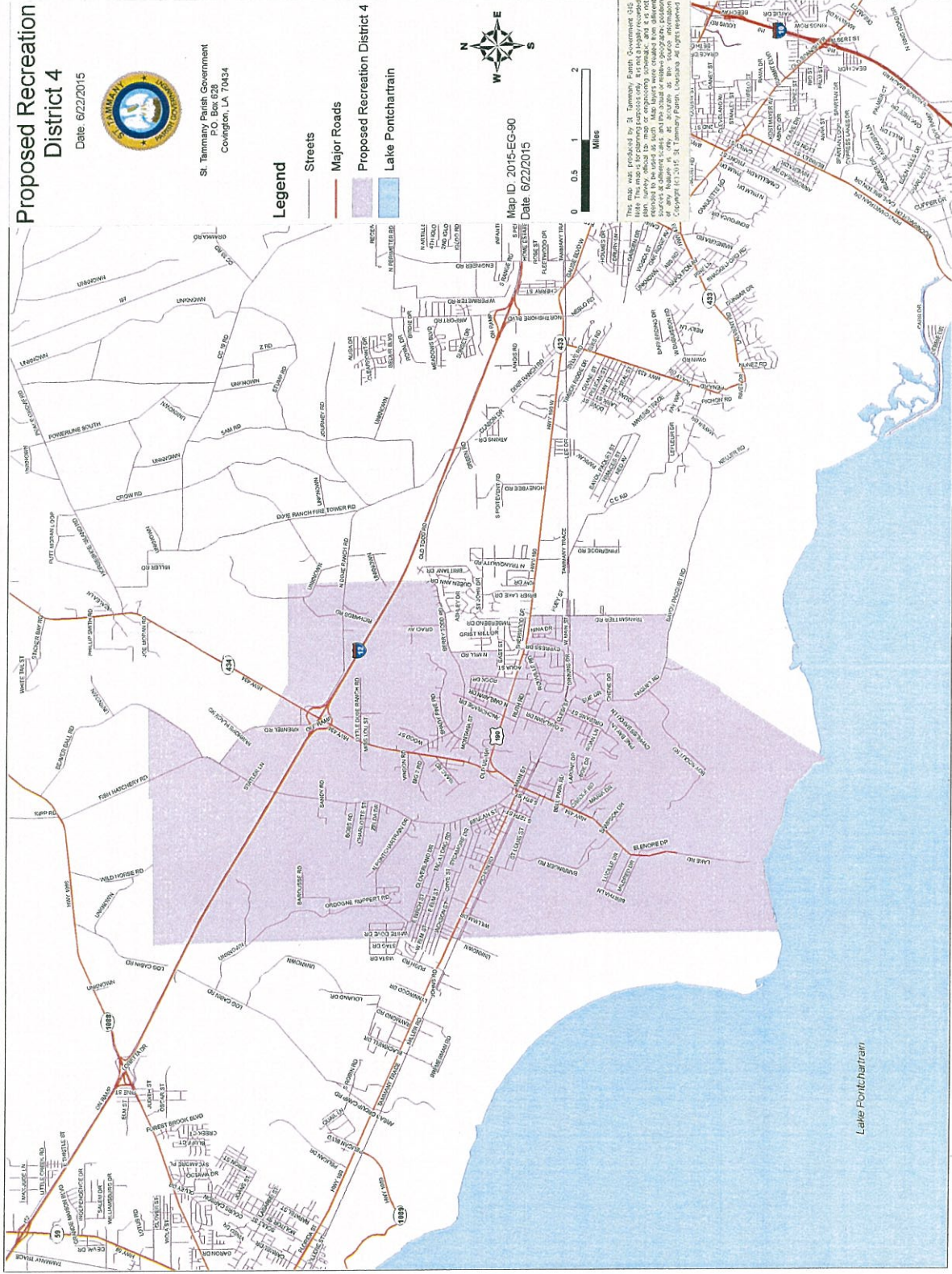
