ORDINANCE TO AMEND ORDINANCE COUNCIL SERIES NUMBER 12-2660 TO ESTABLISH A NO PARKING ZONE ON PORTIONS OF QUEEN ANNE DRIVE, RALEIGH DRIVE, AND DRURY LANE IN HUNTWYCK VILLAGE SUBDIVISION (WARD 9, DISTRICT 14).

WHEREAS, Ordinance C.S. No. 12-2660 adopted on February 2, 2012, established a "No Parking Zone" on portions of Queen Ann Drive and Raleigh Drive within Huntwyck Village Subdivision; and

WHEREAS, the Parish seeks to amend the "No Parking Zone" to include 517 Drury Lane;

WHEREAS, the Parish Department of Public Works is directed to post the appropriate signs at these locations.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that Ordinance Council Series No. 12-2660 be amended effective immediately establishing the "No Parking Zone" within Huntwyck Village Subdivision to include portions of Queen Anne Drive, Raleigh Drive, and 517 Drury Lane.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
