ORDINANCE TO AMEND SECTION 3-400.00 ADOPTION OF STATE LAW CONCERNING EMERGENCY MEDICAL SERVICES OF CHAPTER 3, ARTICLE XII OF THE ST. TAMMANY PARISH CODE OF ORDINANCES.

WHEREAS, Sec. 3-400.00 Adoption of State law Concerning Emergency Medical Services references the adoption of Louisiana Revised Statute 33:4791 for the authority, in part, of St. Tammany Parish to regulate ambulance services in St. Tammany Parish; and

WHEREAS, La.R.S. 33:4791 provides for the regulation of ambulance services by municipalities, and authorizes the parishes of Caddo and Bossier to regulate emergency ambulance operations within the municipalities of said parishes; and

WHEREAS, La.R.S. 33:4791 is not applicable to the regulation of ambulance services by St. Tammany Parish.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that Section 3-400.00 of Article XII Ambulance, Emergency Medical Service, is hereby amended and reenacted as follows::

**ARTICLE XII AMBULANCE, EMERGENCY MEDICAL SERVICE**

**Sec. 3-400.00 Adoption of State Law Concerning Emergency Medical Services**

State law, as defined in Louisiana Revised Statutes 40:1231 et seq., Emergency Medical Service, and Louisiana Revised Statutes ~~33:4791 Regulation of private ambulance services and 33:4791.1 Regulation by Local Governing Authorities of ambulance services, emergency medical services, and aspects attendant to ambulance operation, are hereby adopted by this governing authority.~~

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinances are hereby declared to be severable.

DATE OF ENACTMENT: This Ordinance shall become effective fifteen (15) days after adoption.
