**ORDINANCE TO CHANGE THE PORTION OF GARDEN DRIVE (9G51) FROM EAST STREET TO DEVON AVENUE FROM A "ONE WAY" TRAFFIC ZONE TO A "TWO WAY" TRAFFIC ZONE AND TO POST SIGNS ACCORDINGLY. WARD 9, DISTRICT 11**

WHEREAS, Ordinance C.S. No. 04-0935 adopted August 5, 2004, established a "One Way" traffic zone for portions of Garden Drive during specific school hours; and

WHEREAS, it has been determined that a portion of this "One Way" traffic zone is no longer necessary.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that the portion of Garden Drive (9G51) from East Street to Devon Avenue be changed from "One Way" traffic to "Two Way" traffic and the Department of Public Works post signs accordingly.

BE IT FURTHER ORDAINED that the remaining portion of Garden Drive, designated as "One Way" traffic per Ordinance C.S. No. 04-0935, shall be unchanged.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

EFFECTIVE DATE: This ordinance shall become effective fifteen (15) days after adoption
