AN ORDINANCE TO RENAME RHONDA ROAD EXTENSION (R08A131) AS GUM CREEK ROAD; MARTHA DRIVE (R08A020) AS VIRGINIA DRIVE; AND THE 1700 BLOCK OF ATALIN STREET (R04E228) AS HAZEL DRIVE. WARDS 4 & 8, DISTRICTS 6 & 10

THE PARISH OF ST. TAMMANY HEREBY ORDAINS

SECTION I. To rename Rhonda Road Extension (R08A131) as Gum Creek Road; rename Martha Drive (R08A020) as Virginia Drive; and rename the 1700 block of Atatin Street (R04E228) as Hazel Drive, in conjunction with recommendations of E911 Addressing Office.

SECTION II. The Department of Public Works is directed to obtain and place the appropriate street signs to so designate the roads as indicated above.

SECTION III. If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

SECTION IV. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION V. This Ordinance shall become effective fifteen (15) days after adoption.
