**A RESOLUTION ESTABLISHING ADJUSTED MILLAGE RATE FOR THE YEAR 2004.**

WHEREAS, in accordance with the provisions of Article VII, Section 23 (B) and (C) of the 1974 Louisiana Constitution and R.S.47:1705(B)(1)and (2), a taxing authority is required to adopt Resolutions No. 1 and No. 2 to increase its millage rate(s) after reassessment but not in excess of the prior years maximum authorized millage rate(s).

RESOLUTION NO. 1

NOW, THEREFORE, BE IT RESOLVED BY THE ST. TAMMANY PARISH COUNCIL, in a public hearing held on September 2, 2004, which hearing was conducted in accordance with the open meetings law and the additional requirements of Article VII, Section 23(C) of the Constitution, that the following adjusted millage rate(s) be and they are hereby levied upon the dollar of the assessed valuation of all property subject to ad valorem taxation within St. Tammany Parish for the year 2004, for the purpose of raising revenue:
