ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACCEPT TRANSFER OF OWNERSHIP OF A PORTION OF OAK HARBOR BOULEVARD AND TO INCLUDE SAME INTO THE ROAD MAINTENANCE SYSTEM.  
(WARD 9, DISTRICT 13)

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that the Parish of st. Tammany, through the Office of the Parish President, to accept transfer of ownership of a portion Oak Harbor Boulevard and to include same into the Road Maintenance System. (Ward 9, district 13)

SECTION I: The transfer of ownership of a portion of Oak Harbor Boulevard from the Louisiana Department of Transportation and Development to the Parish of St. Tammany is accepted, and same shall be incorporated into the St. Tammany Parish Selective Road Maintenance System Inventory.

SECTION II: The Parish President and/or C.A.O. is hereby authorized to execute any and all documents necessary in connection with said acceptance of the portion of Oak Harbor Boulevard located southeast of the interchange of Oak Harbor Boulevard and Interstate route I-10 from a point on Oak Harbor Boulevard approximately 0.03 miles southeast of its intersection with the ramps serving the southeast side of the interchange proceeding southeast approximately 0.13 mile to its intersection with I-10 Service Road adjacent to the southeast edge of the right of way.

SECTION III: The Department of Public Works is directed to provide the appropriate maintenance thereto.

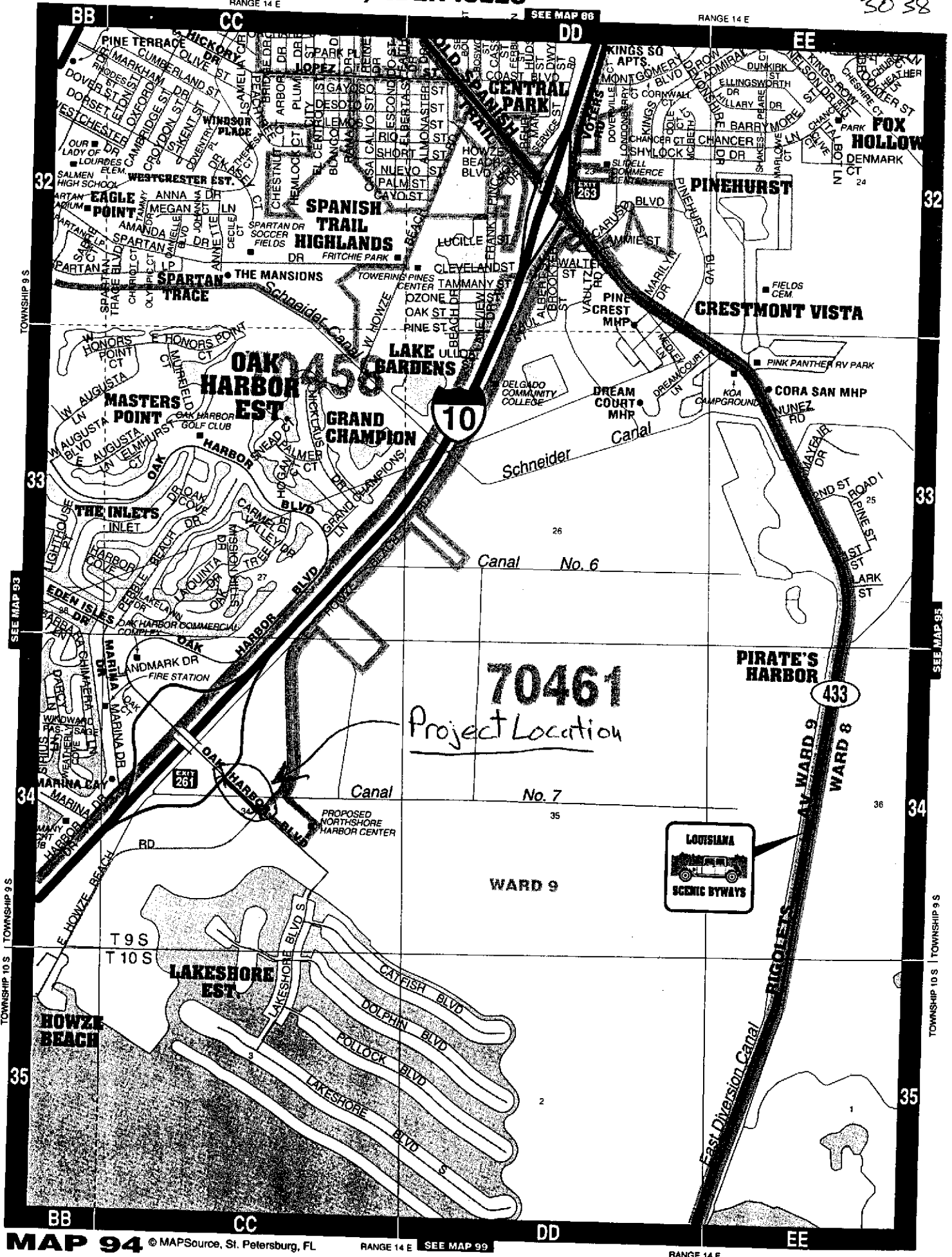
