ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACCEPT THE ACT OF DEDICATION AND DONATION OF MARION LANE, COMMERCIAL WAY NORTH & COMMERCIAL WAY SOUTH, IN ALAMOSA PARK, PHASE 11, AND TO INCLUDE SAME INTO THE ROAD MAINTENANCE SYSTEM AS SHOWN IN EXHIBIT "A" ATTACHED HERETO. (WARD 4, DISTRICT 7)

<u>SECTION I:</u> The Act of Dedication and Donation by Alamosa Park, L.L.C. for Marion Lane, Commercial Way North and Commercial Way South is accepted, and same shall be incorporated into the St. Tammany Parish Selective Road Maintenance System Inventory.

<u>SECTION II:</u> The Parish President and/or C.A.O. is hereby authorized to execute any and all documents necessary in connection with said acceptance of said Marion Lane, Commercial Way North and Commercial Way South.

SECTION III: The Department of Public Works is directed to provide the appropriate maintenance thereto.

<u>SEVERABILITY</u>: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

**<u>REPEAL</u>**: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**EFFECTIVE DATE:** This ordinance shall become effective fifteen (15) days after adoption.


