ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ENTER INTO AND ACCEPT A LATERAL DRAINAGE EASEMENT OF A THIRTY FOOT (30) LATERAL DRAINAGE DITCH SITUATED IN SECTION 11, T8S, R14E FOR INCLUSION INTO THE PARISH MAINTENANCE SYSTEM (WARD 8, DISTRICT 6)

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The Lateral Drainage Easement by Southeast Investments, L.L.C., for a thirty foot (30) lateral drainage ditch is accepted, and same shall be incorporated into the St. Tammany Parish Selective Maintenance System Inventory.

SECTION II: The Parish President and/or C.A.O. is hereby authorized to execute any and all documents necessary in connection with said acceptance of the thirty foot lateral drainage ditch.

SECTION III: The Department of Public Works is directed to provide the appropriate maintenance thereto.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

EFFECTIVE DATE: This ordinance shall become effective fifteen (15) days after adoption.

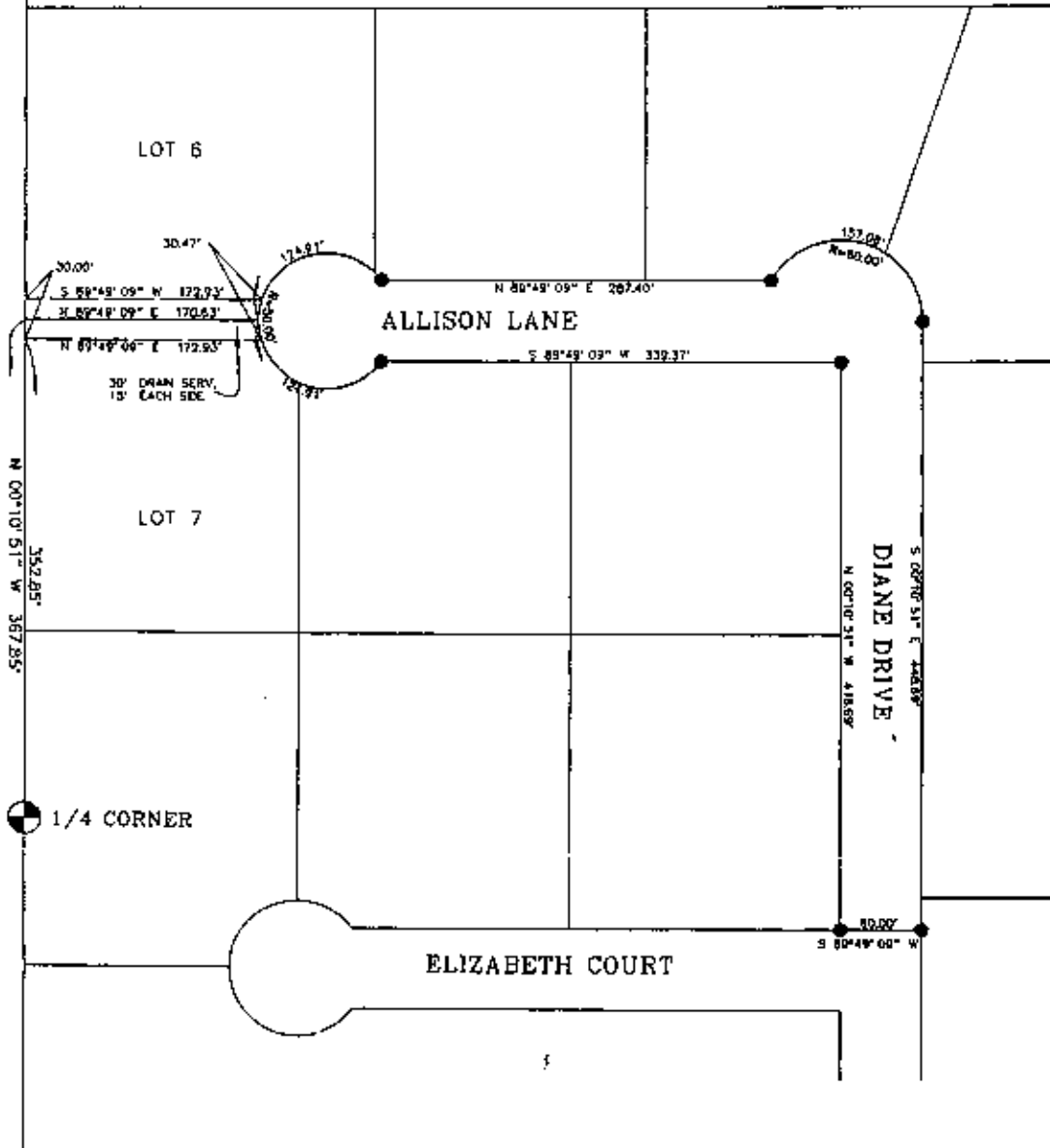
