AN ORDINANCE AMENDING ORDINANCE COUNCIL SERIES NO. 05-1101 WHICH ACCEPTED VARIOUS SUBDIVISIONS INTO THE ROAD & DRAINAGE INVENTORY, TO PROVIDE FOR CLERICAL CORRECTIONS. WARDS 8 & 9, DISTRICTS 8 & 12

WHEREAS, Ordinance Council Series No. 05-1101 was adopted on May 5, 2005, wherein numerous subdivisions and streets were accepted into the Parish Selective Road Maintenance System Inventory; and

WHEREAS, said Ordinance Council Series No. 05-1101 contained certain clerical errors, and

WHEREAS, it is necessary that the errors be corrected to reflect actual subdivisions and roads accepted into the maintenance system;

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: Ordinance Council Series No. 05-1101, adopted May 5, 2005, is hereby amended to reflect the following:

- a) Grand Champions of Oak Harbor, Filing 1 is deleted completely as same is a private subdivison;
- b) Lake Vista Drive and Audubon Lake Drive are deleted completely as neither are located in the Autumn Lakes Subdivision, and are replaced with River Crest Cove, Summer Place Cove, Scenic River Cove and Autumn Lakes Road which are the actual streets located in Autumn Lakes Subdivision.

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.
