AN ORDINANCE TO CORRECT THE ROAD INVENTORY TO INCLUDE SOUTH ROAD, AND AN EXTENSION OF WILSON LANE (R06I012); ALSO TO CORRECT THE DRAINAGE INVENTORY TO INCLUDE DITCH LOCATED OFF DEVAL STREET. WARDS 2, 4, & 6, DISTRICTS 3, 5, & 6

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The St. Tammany Parish Selective Road Maintenance System Inventory is amended to include:

1. South Road, located north off Highway 450, Ward 2, District 3, and
2. A 300' extension of Wilson Lane (R06I012), Ward 6, District 6.

Additionally, the Drainage Inventory shall be amended to include the following ditches:

1. Lateral D04DW01021 located @ 154 DeVal Street, Ward 4, District 5

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.
