WHEREAS, ST. TAMMANY PARISH has filed an Expropriation Suit against appearers and other **PRIETO HEIRS** on December 29, 2004, being Suit No. 2004-16097, Division I of the 22nd Judicial District Court for the Parish of St. Tammany, State of Louisiana, as to two [2] properties [Parcel 1: Lots 31 & 32, The Birg Blvd. Subdivision.; and Parcel 2: a 15.37' x 30.0' parcel]

WHEREAS, ST. TAMMANY PARISH, as Plaintiff, had two [2] appraisals made of the properties to be expropriated [Michael Breeding - \$34,500.00; Murphy - \$71,000.00], averaged the two appraisals and offered \$52,750.00 for the property to be taken for public use.

WHEREAS, LSA R.S. 31:149 et seq allows a property owner in an expropriation proceeding to reserve minerals in perpetuity, and appearers respectively reserve their individual mineral interest as provided by law.

NOW THEREFORE, the said **CLAY C. PRIETO, DAVID M. MOORE, MARGERY MOORE HANISEE**, and **GOLDEN PROPERTIES, LLC** do hereby transfer, donate and deliver fee title of the hereafter described property to **ST. TAMMANY PARISH**, for use in widening Harrison Avenue [Dog Pound Road], to-wit:

**Parcel 1:** All that certain parcel of ground being situated in Section 12, Township 7 South, range 11 East, St. Tammany Parish, Louisiana and being more fully described as Lots 31 & 32 in Block 31, Northern Division of Big Boulevard subdivision.

**Parcel 2:** All that certain parcel of ground being situated in Section 12, Township 7 South, Range 11 East, St. Tammany Parish, Louisiana and being more fully described as a parcel of ground commencing at the intersection of the southern right of way of Harrison Avenue and the western right of way of Louisiana State Highway 59 and measuring 30 feet front on Louisiana State Highway 59 by a depth of 15.37 feet, more or less, front on Harrison Avenue, between equal and parallel lines.

TAMMANY PARISH, reserving all minerals in perpetuity as provided under LSA R.S. 31:149, et seq.

NOW INTO THIS ACT intervenes JOAN PRIETO DOOLITTLE, who declares that she has previously donated her entire interest in **Parcel 1** noted above unto ROBERT T. DOOLITTLE, JR., but who nonetheless donates any interest she has or might have to **Parcel 1**, and further donates any interest she has or might have, being her one twelfth [1/12] interest in **Parcel 2** unto ST. TAMMANY PARISH, reserving all minerals in perpetuity as provided under LSA R.S. 31:149, et seq.

The consideration for the donation herein made is appearers wish to assist St. Tammany Parish by making access from Harrison Avenue onto and off La. Highway 59 more safe for public use. The donors declare that the property herein donated is but a small portion of the property owned by them respectively, and that it is not necessary for his, her, or it's maintenance and/or support.
