AN ORDINANCE TO CORRECT THE ROAD INVENTORY TO INCLUDE A PORTION OF 5<sup>TH</sup> STREET, A PORTION OF 10<sup>TH</sup> STREET, 11<sup>TH</sup> STREET, BROWN'S ROAD, PROSPER STREET, AND BERNARD ROAD; ALSO TO CORRECT THE DRAINAGE INVENTORY TO INCLUDE DITCH LOCATED OFF DELOS ROAD. WARDS 2, 3, 4, 7 & 9, DISTRICTS 3, 4, 7, & 14

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

**SECTION I:** The St. Tammany Parish Selective Road Maintenance System Inventory is amended to include:

1. A portion of 5<sup>th</sup> Street, Town of New Claiborne, Ward 3, District 3,
2. A portion of 10<sup>th</sup> Street, Chinchuba Subdivision, Ward 4, District 4,
3. 11<sup>th</sup> Street, Chinchuba Subdivision, Ward 4, District 4
4. Brown's Road, located west off North Hay Hollow Road, Ward 2, District 3
5. Prosper Street, located off Isaac Street, Ward 7, District 7 and
6. Bernard Road, located off Mineola Street, Ward 9, District 14

Additionally, the Drainage Inventory shall be amended to include the following ditches:

1. Lateral D03EW01029 located @ 77069 Delos Road, Ward 3, District 3

**SECTION II:** The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

**SECTION III:** If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

**SECTION IV:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SECTION V:** This ordinance shall become effective fifteen (15) days after adoption.
