SECTION I: The Act of Dedication and Donation by Jamie Wilson, et al for Rue de la Parc is accepted, and same shall be incorporated into the St. Tammany Parish Selective Road Maintenance System Inventory.
SECTION II: The Parish President and/or C.A.O. is hereby authorized to execute any and all documents necessary in connection with said acceptance of Rue de la Parc.




