ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACCEPT TRANSFER OF OWNERSHIP OF A PORTION OF OAK HARBOR BOULEVARD(WARD 9, DISTRICT 12)
THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that St. Tammany Parish is agreeable to accept ownership of whatever rights the Louisiana Department of Transportation and Development may own in and to the following described property and accept all future liabilities associated therewith for its operation and maintenance as a parish route;
The portion of Oak Harbor Boulevard located southeast of the interchange of Oak Harbor Boulevard and Interstate Route I-10 from a point on Oak Harbor Boulevard approximately 0.03 miles southeast of its intersection with the ramps serving the southeast side of the interchange proceeding southeast approximately 0.13 mile to its intersection with the I-16 service road adjacent to southeast edge of the right or way.
SECTION I: That the St. Tammany Parish Council will accept ownership of whatever rights the Department may own in and to the aforesaid described herein as a binding agreement between the State of Louisiana and the Parish of St. Tammany provided the Department of Transportation and Development accepts the agreement described herein within 90 days of the adoption of this resolution.
SECTION II: That the St. Tammany Parish Council authorizes the Parish President and/or CAC of St. Tammany Parish to execute the instruments to transfer the aforesaid property described herein
<u>SEVERABILITY:</u> If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repeated.
EFFECTIVE DATE: This ordinance shall become effective fifteen (15) days after adoption.
