RESOLUTION TO AMEND ORDINANCE COUNCIL SERIES NO. 04-0988, 2005-2009 CAPITAL IMPROVEMENT BUDGET AND PROGRAM, TO MAKE CHANGES TO THE COUNCIL DISTRICT 13 ROAD LIST, TO INCLUDE LYNN AVENUE.
