ORDINANCE AMENDING AND REENACTING ST. TAMMANY PARISH CODE OF ORDINANCES, CHAPTER 12 LICENSES, TAXATION AND REGULATIONS, ARTICLE II, ST. TAMMANY PARISH [OCCUPATIONAL] LICENSE TAX, SECTIONS 12-016.10 THROUGH 12-016.38, TO ENACT NEW SECTION 12-016.39 FAILURE TO OBTAIN LICENSE WHEN REQUIRED; PENALTY.

WHEREAS, pursuant to the authority granted in Louisiana Revised Statutes Title 47, Subtitle 2, Chapter 3, the Parish of St. Tammany Parish adopted Article II of Chapter 12, the "St. Tammany Parish License Tax" (Ord. No. 608, Art. IX, Bk. 7, P. 452; Ord. No. 87-815, adopted 06/18/87; amended and corrected by Ord. No. 87-871, adopted 10/15/87); and

WHEREAS, to insure compliance with the provisions and requirements of the St. Tammany Parish Ordinances adopted under the authority of Title 47, including the provisions of La. R. S 47:350(A);

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that the St. Tammany Parish Code of Ordinances, Chapter 12 Licenses, Taxation and Regulations, Article II St. Tammany Parish [Occupational] License Tax, is hereby amended and reenacted to enact new Section 12-016.39 Failure to Obtain License When Required; Penalty:

Section 12-016.39 Failure to Obtain License When Required; Penalty

It is strictly prohibited for any person who is required to obtain a license under the provisions of Section 12-016.10 through Section 12-016.38 to conduct any business or activity governed by the provisions thereof, prior to obtaining the required license. A violation of this requirement shall constitute a misdemeanor, and any person convicted thereof shall be fined not more than two hundred dollars per day for each day the violation continues or imprisoned for not more than thirty (30) days, or both.

REPEAL: The amendment, which is limited in its scope and application to the particular subparagraph and section, shall not be held to repeal any previously existing ordinance or parts of ordinances.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinances are hereby declared to be severable.

DATE OF ENACTMENT: This Ordinance shall become effective fifteen (15) days after adoption.
