ORDINANCE TO RENAME OAK HARBOR BOULEVARD EAST AS LAKESHORE BOULEVARD EAST. WARD 9, DISTRICT 13

WHEREAS, Tammany Holding Corporation is developing Lakeshore Estates Planned Unit Development and the Lakeshore Village Planned Unit Development, which consist of about 3000 acres; and

Whereas, there are two streets which will become major streets of several miles in length and which to date consist of only a few hundred yards each but which have been named Oak Harbor Boulevard East and Harbor Center Boulevard, which names are not consistent with the overall plan of development of the aforesaid property and should be changed as soon as possible to reflect the relationship of these major arteries into Lakeshore.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS

SECTION I. To rename Oak Harbor Boulevard East as Lakeshore Boulevard East, in conjunction with recommendations of E911 Addressing Office.

SECTION II. The Department of Public Works is directed to obtain and place the appropriate street signs to so designate the roads as indicated above.

SECTION III. If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

SECTION IV. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION V. This Ordinance shall become effective fifteen (15) days after adoption.
