ORDINANCE ESTABLISHING A "NO THRU TRUCKS" ZONE ON PACE STREET (R08W008) WARD 8, DISTRICT 14

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: A "NO THRU TRUCKS" ZONE is hereby established on Pace Street (R08w008), as indicated on the attached traffic plan by the Department of Engineering. WARD 8, DISTRICT 14.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at these locations.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION IV: This ordinance shall become effective fifteen (15) days after adoption.
