ORDINANCE ESTABLISHING 3-WAY STOP INTERSECTIONS AT THE CORNERS OF QUINCY AVENUE & 1<sup>ST</sup> STREET AND AT MARIGOLD DRIVE & MARIA AVENUE. WARD 3, DISTRICT 5.

WHEREAS, certain intersections have become serious concerns for the parish and area residents due to traffic volumes. In the interest of safety and the well being of the residents, motorist, and emergency response vehicles, it is the desire of this governing authority to implement more effective traffic controls at the referenced intersections.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

**SECTION I:** A "3-WAY STOP INTERSECTION" is hereby established at the intersections of Quincy Avenue (R-03-L-048), and 1<sup>st</sup> Street (R-03-L-038); and at the intersection of Marigold Drive (R-03-L-081) and Maria Avenue (R-03-L-082) Ward 3, District 5.

**SECTION II:** The Parish Departments of Engineering and Public Works are directed to install the appropriate signs (3 -way Stop Signs) at the two intersections without delay.

**SECTION III:** If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

**SECTION IV:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SECTION V:** This ordinance shall become effective immediately upon final adoption.
