- 6. Check for needed signage replacement;
- 7. Check for needed blue reflector replacement;
- 8. Remove debris and trash from detention ponds and all ditches;
- 9. Roadways need to be broomed for a meaningful inspection to be made.

The following punch list items remain:

- (1.) All roadways are covered with extensive amounts of silt caused from erosion from lot fill. Inadequate silt abatement measures are being employed at this site. Silt is flowing into catch basins and eventually into the subsurface drainage. The developer's engineer must certify that all catch basins and subsurface drains have been cleaned out before this Warranty Obligation can be released. This situation must be improved immediately;
- (2.) Replace all signage and blue reflectors, where needed.



The following is a response to the final subdivision staff analysis report dated June 7, 2005.

- Item 2A Per a conversation with the developer, the contractor is to remove the existing rip-rap located at the three (3) in flow areas of Pond #3. The contractor shall regrade and compact the existing in flow ditches and place a non woven geotectile fabric (Contech C-70NW) or approved equal at the bottom of the ditch. On top of the fabric, the contractor shall place the rip-rap and grout the bottom of the rip-rap with flowable grout. The contractor shall place the rip-rap in the locations identified on the attached sketch.
- Item 2B The contractor shall remove any silt that has accumulated at the bottom of the pond and regrade the pond slopes. The contractor shall place erosion mats, hydro seed, and water until a mature stand of grass has been established.
- Item 2C Attached is a drawing that shows the ponds and maximum water surface elevation in each pond.
- Item 2D Per our conversation, detention Ponds #1 & #2 are designed to have emergency
  over flows at the top of the control structure as well as emergency spillways. The
  emergency spillways are designed to discharge to the existing ditch located between
  Ponds #1 & #2.
- Item 2E Please see attached As-Built plan for revised nomenclature.
- Item 2F Per our conversation, the detention pond does meet the 25, 50 and 100 year storm events for a 2 hour and 24 hour duration storm. Refer to previous As-Built Drainage Synopsis.
- Item 2G Contractor will add rip-rap adjacent to the culverts as shown on the design plans.
- Item 2H The contractor shall regrade and shape the existing swale ditch between the 15" culvert and the drainage channel to allow for a more direct approach. The contractor

- shall grade the swale ditch with a 2 ft. wide bottom and 3 to 1 side slopes and hydro seed until a healthy stand of grass has been established.
- Item 2I See attached plat for revised dedication statement.

Duplantis Design Group, PC has furnished two (2) copies of the As-Built cross sections taken at 50 ft. intervals along Holiday Square Boulevard for staffs review and approval. The construction of the revised pond appears to be in compliance with the plans and parish requirements.

The developer was notified on September 27, 2006 by the Department of Engineering of the punch list items required and for his engineer to certify to this office at least sixty (60) days prior to the expiration of the obligation, that the punch list has been completed. If not, the obligation will be automatically called.

This office has not received such notification. Therefore this obligation would normally be called. However, in accordance with Resolution Council Series No. C-1528, passed at September 28, 2005, Special Parish Council meeting regarding Hurricane Katrina, the Warranty Obligation will be extended for one (1) year from the expiration date shown.

The following punch list items were submitted to the developer on 09/27/2006 and remain:

- 1. The roadway needs to be broomed for a meaningful inspection to be made;
- 2. Shoulders in front of houses must be sodded and swale ditches dressed to have positive flow;
- 3. The outfall culverts for S.D.S.A. #31 and #32 are holding water; the downstream ditches need to be cleaned out so that the detention ponds will drain to the elevation of the invert of the outfall culverts;
- 4. The subsurface drainage flush grates are eroding at the entrances; the grates need to be restored;
- 5. Some reflectors need to be replaced;
- 6. The discharge end of the 24" RPVCCP does not have the slope pavement constructed and erosion is active; additional downstream rip rap is required to stop this erosion;
- 7. Erosion is active on each side of the main culvert crossing (Bridge); erosion must be checked;
- 8. The silt within the 3 88" x 54" culverts need to be removed;
- 9. Inspect and verify that the slope pavement is constructed at the end of 30" RPVCCP between Lots 50 and 51:
- 10. Concrete waste must be removed from road right-of-way at northern end of Phase 2.

- 5. Remove debris from all Parish R.O.W.'s;
- 6. Replace all signage and furnish an AS-BUILT drawing indicating that signs have been replaced in accordance with approved signage plan;
- 7. See attached letter dated 01/26/2006 regarding bare slopes of pond.

Dear Mr. Diggs:

An inspection was made of the site on January 25, 2006. The inspection disclosed that the concrete overflow weir has not yet been constructed at the Yvonne Avenue Pond. The weir must be constructed in accordance with the approved sketch previously furnished.

If the concrete weir is not constructed before the next heavy rainfall we are concerned that additional erosion will occur requiring additional restoration by you. Therefore it will be necessary that you construct the weir as soon as possible but at least within the next seven days. Please advise this office when the work is completed.

In addition to the above it was observed that the linear detention pond was hydro seeded. However, some of the grass has not successfully taken and some slopes are still bare. This condition will be inspected upon expiration of the Warranty Obligation and may need to be rectified at that time.

Again, please advise this office upon completion of the weir.
