ORDINANCE TO AMEND ORDINANCE COUNCIL SERIES NO. 01-0310 TO REMOVE MOSSY OAKS SUBDIVISION FROM THE SUBDIVISIONS BEING ACCEPTED INTO THE MAINTENANCE SYSTEM; ALSO AMENDING ORDINANCE COUNCIL SERIES NO. 05-1101 TO REMOVE GRAND CHAMPIONS OF OAK HARBOR, FILING 1 FROM THE SUBDIVISIONS BEING ACCEPTED INTO THE MAINTENANCE SYSTEM. WARDS 8 & 9, DISTRICTS 9 & 12

WHEREAS, Ordinance Council Series No. 01-0310, adopted May 3, 2001 accepted certain finalized subdivisions into the Parish road maintenance system, of which Mossy Oaks Subdivision was included erroneously, and is in fact privately maintained; and

WHEREAS, Ordinance Council Series No. 05-1101, adopted May 5, 2005 *accepted certain finalized subdivisions into the Parish road maintenance system, of which Grand Champions of Oak Harbor, Filing 1 was included erroneously, and is in fact privately maintained; and*

WHEREAS, it is the desire of this Council that these errors be corrected and the subdivisions included in the above mentioned ordinances be deleted from same; and also be removed from the Parish's road maintenance system; and

WHEREAS, specific roads to be removed from the inventory are Mossy Oak Drive located within Mossy Oak Subdivision, Ward 8, District 9; and Grand Champion Lane, Nicklaus Drive, and Palmer Court located within Grand Champions of Oak Harbor, Filing 1, Ward 9, District 12.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: Ordinance Council Series No. 01-0310, adopted May 3, 2001 is hereby amended to remove Mossy Oaks Subdivision from the subdivisions being accepted into the maintenance system as said Mossy Oaks Subdivision is privately maintained.

SECTION II: Ordinance Council Series No. 05-1101, adopted May 5, 2005 is hereby amended to remove Grand Champions of Oak Harbor, Filing 1 from the subdivisions being accepted into the maintenance system as said Grand Champions of Oak Harbor, Filing 1 is privately maintained.

SECTION III: The Parish Department of Public Works is hereby directed to remove Mossy Oak Drive, Grand Champion Lane, Nicklaus Drive and Palmer Court from the Parish Road Maintenance System.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.
