A Resolution approving the holding of an election in St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana, on Saturday, September 30, 2006, to authorize the levy of a special tax therein.

WHEREAS, the Board of Commissioners of St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana (the "Governing Authority"), acting as the governing authority of St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana (the "District"), adopted a resolution on June 26, 2006, calling a special election in the District on Saturday, September 30, 2006, to authorize the levy of a special tax therein; and

WHEREAS, the governing authority of the District has requested that this Parish Council, acting as the governing authority of the Parish of St. Tammany, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries to levy and collect the special tax provided for therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Parish Council to approve the holding of said election and in the event that the election carries, to levy and collect the special tax provided for therein;

NOW, THEREFORE, BE IT RESOLVED by the Parish Council of the Parish of St. Tammany, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana, this Parish Council hereby approves the holding of an election in the District, on Saturday, September 30, 2006, at which election there will be submitted the following proposition, to-wit:

## **PROPOSITION**

SUMMARY: 10 YEAR, 10.12 MILLS PROPERTY TAX CONTINUATION FOR ACQUIRING, CONSTRUCTING, IMPROVING, MAINTAINING AND/OR OPERATING FIRE PROTECTION FACILITIES AND EQUIPMENT IN AND FOR ST. TAMMANY FIRE DISTRICT NO. 6, INCLUDING EMERGENCY EQUIPMENT AND SUPPLIES, AND PAYING THE COST OF OBTAINING WATER FOR FIRE PROTECTION PURPOSES AND PAYING CHARGES FOR FIRE HYDRANT RENTALS AND SERVICE.

Shall St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana (the "District"), levy a special tax of ten and twelve hundredths (10.12) mills on all property subject to taxation within the District for a period of ten (10) years, beginning with the year 2006 and ending with the year 2015, for the purpose of acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment in and for the District, including emergency equipment and supplies, and paying the cost of obtaining water for fire protection purposes and paying charges for fire hydrant rentals and service?
