ORDINANCE AUTHORIZING THE OFFICE OF THE PARISH PRESIDENT TO ACCEPT THE DEDICATION & DONATION OF APPROXIMATELY 3.76 ACRES BY SLIDELLA, II, LLC, AS SHOWN IN EXHIBIT "A" TO BE USED IN CONJUNCTION WITH THE AIRPORT ROAD IMPROVEMENTS PROJECT. (WARD 9, DISTRICT 11)

WHEREAS, the St. Tammany Parish Government is charged with protecting the safety and welfare of the citizens of the parish; and

WHEREAS, Slidella, II, LLC, as the titled owner of property fronting Airport Road as described in Exhibit "A", has proposed a donation of a portion of Tract I, Section 19, T-8-S, R-14-E, to the Parish of St. Tammany; and

WHEREAS, there is a public need to utilize the subject property to improve area infrastructure and to enhance the quality of life in this parish; and

WHEREAS, it is the desire of St. Tammany Parish Government to accept this donation from Slidella, II, LLC.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS to authorize the Office of the Parish President to accept the Dedication & Donation of approximately 3.76 acres by Slidella, II, LLC, as shown in Exhibit "A" (attached hereto) to be used in conjunction with Airport Road improvement projects in Ward 9, District 11.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon final adoption.

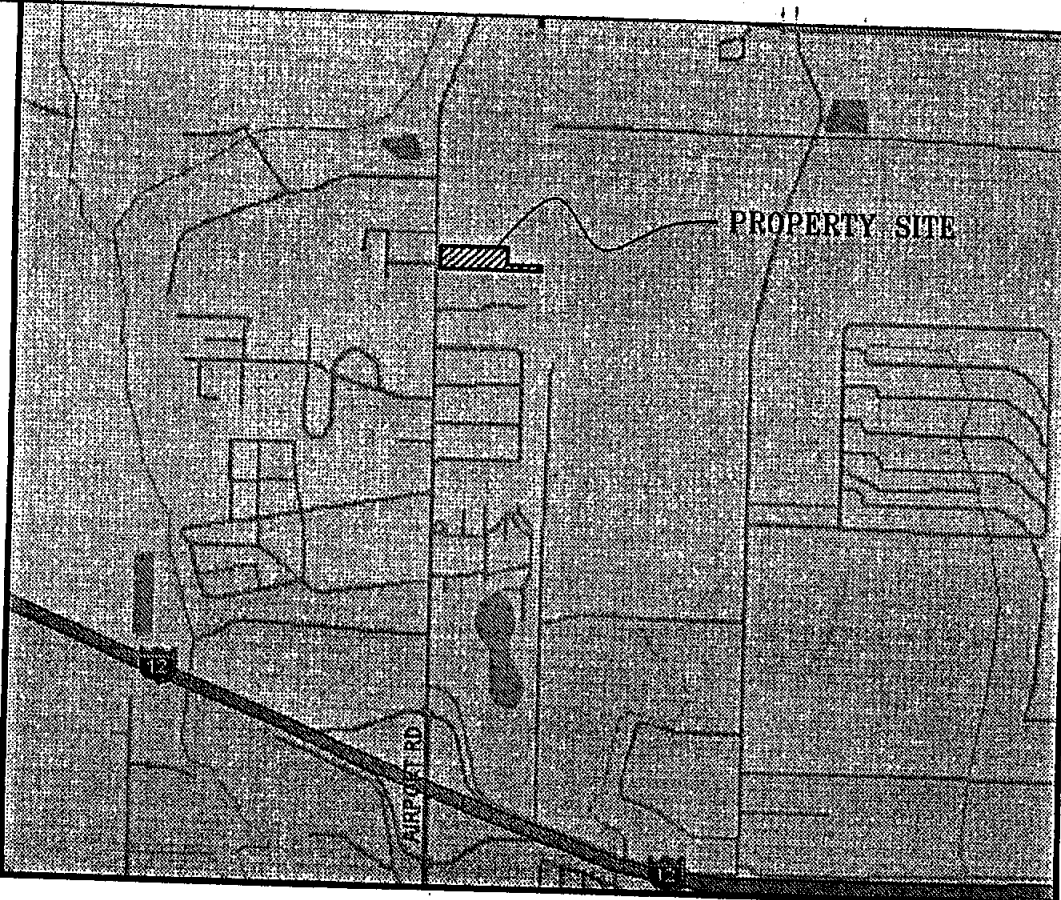

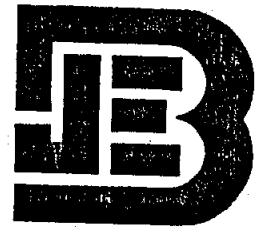
