ORDINANCE TO AMEND THE CODE OF ORDINANCES, CHAPTER 16,  
PROVIDING FOR THE AMENDMENT OF THE BOUNDARIES OF  
RECREATION DISTRICT NO. 10 AND RECREATION DISTRICT NO. 11,  
AND TO PROVIDE FOR REPEAL, SEVERABILITY, AND DATE OF  
ENACTMENT.

WHEREAS, the St. Tammany Parish Police Jury adopted Ordinance No. 90-1274, dated May 17, 1990, creating Recreation District No. 10, which boundaries originally comprised Ward 3 of the Parish less and except the City of Covington. Thereafter, the boundaries of Recreation District No. 10 were amended by Ord. No. 91-1408, adopted February 21, 1991, to comprise all of Ward 3 of St. Tammany, including all areas within the corporate limits of the City of Covington; and

WHEREAS, in addition, by Ordinance No. 92-1570, dated February 20, 1992, the St. Tammany Parish Police Jury created Recreation District No. 11, which boundaries coincide with that of Ward Ten and include the Town of Abita Springs; and

WHEREAS, the St. Tammany Parish Council adopted Ordinance C.S. No. 00-0211, dated October 5, 2000, amending the boundaries of Recreation District No. 10 by removing that portion of land comprising River Oaks Subdivision and placing said area of land within the boundaries of Recreation District No. 1; and

WHEREAS, the St. Tammany Parish Council adopted Ordinance C.S. No. 06-\_\_\_\_\_, dated May 4, 2006, amending the boundaries of Recreation District No. 10 by removing that area of land comprising Parish Voting Precinct 307 as it existed at the time of adoption of and as more fully described in said ordinance, and placing said area of land within the boundaries of Recreation District No. 1; and

WHEREAS, the Parish Council now desires to amend the boundaries of Recreation District No. 10 and Recreation District No. 11, and affecting an area comprising Parish Voting Precincts 305, 308, 309, 311 and A04, in their entirety, and a portion of Precinct A02, less and except any properties contained within said precincts and also within the municipal boundaries of the City of Covington; to remove the area more fully described below from Recreation District No. 10 and add said area to Recreation District No. 11.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that under and by virtue of the authority conferred by Chapter 11, Title 33 of the Louisiana Revised Statutes of 1950 and other constitutional and statutory authority supplemental thereto, it is the intention of the Parish Council to amend the boundaries of Recreation District No. 10 to remove from its jurisdictional limits an area comprising the boundaries of Parish Voting Precincts 305, 308, 309, 311, A04 and a portion of Precinct A02, less and except any properties within the municipal boundaries of the City of Covington, as established by Ordinance C.S. No. 01-0415, adopted December 20, 2001, and as more fully described as follows, to-wit:

Commence at the intersection of Hwy. 190 and 9<sup>th</sup> Avenue, also the point of beginning; thence follow Hwy. 190 north to its intersection with Hwy. 21 (a/k/a Military Road); thence follow Hwy. 21 north and northeast to its intersection with Hwy. 36; thence follow Hwy. 36 east, southeast and south to its intersection with Level Street; thence follow Level Street west to its intersection with Hwy. 59; thence follow Hwy. 59 south to its intersection with Parker Drive; thence follow Parker Drive northwest to its intersection with Soell Drive; thence follow Soell Drive northeast to its intersection with 11th Avenue; thence follow 11th Avenue northwest to its intersection with North Street; thence follow North Street

southwest to its intersection with Lincoln Street; thence follow Lincoln Street west to its intersection with 11<sup>th</sup> Street; thence follow 11<sup>th</sup> Street south to its intersection with Madison Avenue; thence follow Madison Avenue west to its intersection with 7<sup>th</sup> Street; thence follow 7<sup>th</sup> Street north to its intersection with Quincy Avenue; thence follow Quincy Avenue west to its intersection with K Street; thence follow K Street south to its intersection with 9<sup>th</sup> Avenue; thence follow 9<sup>th</sup> Avenue west to its intersection with Hwy.190, also the point of beginning.

IT IS FURTHER ORDAINED that in compliance with the provisions of Chapter 11, Title 33 of the Louisiana Revised Statutes of 1950 and other constitutional and statutory authority supplemental thereto, it is the intention of the Parish Council to amend the boundaries of Recreation District No. 11 to add within its jurisdictional limits an area comprising the boundaries of Parish Voting Precincts 305, 308, 309, 311, A04, and a portion of Precinct A02, less and except any properties within the municipal boundaries of the City of Covington, as established by Ordinance C.S. No. 01-0415, adopted December 20, 2001, and as more fully described as follows, to-wit:

Commence at the intersection of Hwy. 190 and 9<sup>th</sup> Avenue, also the point of beginning; thence follow Hwy. 190 north to its intersection with Hwy. 21 (a/k/a Military Road); thence follow Hwy. 21 north and northeast to its intersection with Hwy. 36; thence follow Hwy. 36 east, southeast and south to its intersection with Level Street; thence follow Level Street west to its intersection with Hwy. 59; thence follow Hwy. 59 south to its intersection with Parker Drive; thence follow Parker Drive northwest to its intersection with Soell Drive; thence follow Soell Drive northeast to its intersection with 11<sup>th</sup> Avenue; thence follow 11<sup>th</sup> Avenue northwest to its intersection with North Street; thence follow North Street southwest to its intersection with Lincoln Street; thence follow Lincoln Street west to its intersection with 11<sup>th</sup> Street; thence follow 11<sup>th</sup> Street south to its intersection with Madison Avenue; thence follow Madison Avenue west to its intersection with 7<sup>th</sup> Street; thence follow 7<sup>th</sup> Street north to its intersection with Quincy Avenue; thence follow Quincy Avenue west to its intersection with K Street; thence follow K Street south to its intersection with 9<sup>th</sup> Avenue; thence follow 9<sup>th</sup> Avenue west to its intersection with Hwy. 190, also the point of beginning.

The Parish Council having met in open and public session at its regular meeting place, the Council Chambers, 21490 Koop Drive, Mandeville, Louisiana, on Thursday, June 1, 2006, at 6:00 p.m. as duly advertised and required by law, for the purpose of hearing any and all objections to the amendments of the boundaries of the aforesaid Recreation Districts, and, after disposing of any and all objections, the Parish Council now adopts this ordinance providing for same.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after final adoption.
