RESOLUTION COUNCIL SERIES NO. C-1663

RESOLUTION OF INTENTION TO AMEND THE BOUNDARIES OF RECREATION DISTRICT NO. 1 AND RECREATION DISTRICT NO. 10, AND DIRECTING THE COUNCIL CHAIRMAN TO GIVE DUE NOTICE THEREOF.

WHEREAS, by Ordinance No. 623, dated April 17, 1975, the St. Tammany Parish Police Jury created Recreation District No.1, which boundaries coincide with that of Ward Four and include the City of Mandeville; and

WHEREAS, in addition, the St. Tammany Parish Police Jury adopted Ordinance No. 90-1274, dated May 17, 1990, creating Recreation District No. 10, which boundaries originally comprised Ward 3 of the Parish less and except the City of Covington. Thereafter, the boundaries of Recreation District No. 10 were amended by Ord. No. 91-1408, adopted February 21, 1991, to comprise all of Ward 3 of St. Tammany, including all areas within the corporate limits of the City of Covington; and

WHEREAS, the St. Tammany Parish Council adopted Ordinance C.S. No. 00-0211, dated October 5, 2000, amending the boundaries of Recreation District No. 10 by removing that portion of land comprising River Oaks Subdivision and placing said area of land within the boundaries of Recreation District No. 1; and

WHEREAS, the Parish Council now desires to further amend the boundaries of Recreation District No. 10 and Recreation District No. 1, and affecting an area comprising Parish Voting Precinct 307, to remove the area described below from Recreation District No. 10 and add said area to Recreation District No. 1.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that under and by virtue of the authority conferred by Chapter 11, Title 33 of the Louisiana Revised Statutes of 1950 and other constitutional and statutory authority supplemental thereto, it is the intention of the Parish Council to amend the boundaries of Recreation District No. 10 to remove from it's jurisdictional limits an area comprising the boundaries of Parish Voting Precinct 307 as established by Ordinance C.S. No. 01-0393, and as more fully described as follows, to-wit:

Commence at the intersection of Hwy. 190 and Ponchitalawa Creek, also the point of beginning; thence follow Ponchitalawa Creek east, northeast, east, northwest, northeast, east, northwest, northeast, southeast, and northeast to its intersection with Hwy. 59; thence follow Hwy. 59 north to its intersection with Parker Road; thence follow Parker Road northwest to its intersection with Soell Drive; thence follow Soell Drive northeast to its intersection with 11th Avenue; thence follow 11th Avenue northwest to its intersection with North Street; thence follow North Street southwest to its intersection with Lincoln Street; thence follow Lincoln Street west to its intersection with 11th Street; thence follow 11th Street south to its intersection with Madison Avenue; thence follow Madison Avenue west to its intersection with 7th Street; thence follow 7th Street north to its intersection with Quincy Avenue; thence follow Quincy Avenue west to its intersection with K Street; thence follow K Street south to its intersection with 9th Avenue; thence follow 9th Avenue west to its intersection with Hwy. 190; thence follow Hwy. 190 southwest, south, and southeast to its intersection with Ponchitalawa Creek, also the point of beginning.

BE IT FURTHER RESOLVED that in compliance with the provisions of Chapter 11, Title 33 of the Louisiana Revised Statutes of 1950 and other constitutional and statutory authority supplemental thereto, it is the intention of the Parish Council to amend the boundaries of Recreation District No. 1 to add within it's jurisdictional limits an area comprising the boundaries of Parish Voting Precinct 307 as established by Ordinance C.S. No. 01-0393, and as more fully described as follows, to-wit:

Commence at the intersection of Hwy. 190 and Ponchitalawa Creek, also the point of beginning; thence follow Ponchitalawa Creek east, northeast, east, northwest, northeast, east, northwest, northeast, southeast, and northeast to its intersection with Hwy. 59; thence follow

Hwy. 59 north to its intersection with Parker Road; thence follow Parker Road northwest to its intersection with Soell Drive; thence follow Soell Drive northeast to its intersection with 11th Avenue; thence follow 11th Avenue northwest to its intersection with North Street; thence follow North Street southwest to its intersection with Lincoln Street; thence follow Lincoln Street west to its intersection with 11th Street; thence follow 11th Street south to its intersection with Madison Avenue; thence follow Madison Avenue west to its intersection with 7th Street; thence follow 7th Street north to its intersection with Quincy Avenue; thence follow Quincy Avenue west to its intersection with K Street; thence follow K Street south to its intersection with 9th Avenue; thence follow 9th Avenue west to its intersection with Hwy. 190; thence follow Hwy. 190 southwest, south, and southeast to its intersection with Ponchitalawa Creek, also the point of beginning.

The Parish Council shall meet in open and public session at its regular meeting place, the Council Chambers, 21490 Koop Drive, Mandeville, Louisiana, on Thursday, April 6, 2006, at 6:00 p.m., for the purpose of hearing any and all objections to the amendments of the boundaries of the aforesaid Recreation Districts, and, after disposing of all objections, the Parish Council shall, if it determines to do so, adopt the necessary ordinance providing for same.

BE IT FURTHER RESOLVED that the Chairman of the Parish Council is hereby ordered and directed to issue a Notice of Intention of the Parish Council to amend the boundaries of the said Districts, which notice shall embrace substantially all things set forth in this resolution, shall be substantially in the form attached as Exhibit "A" hereto, and shall be published in accordance with the provisions of law.

NOTICE OF INTENTION

Pursuant to the provisions of a resolution adopted by the Council of the Parish of St. Tammany, State of Louisiana, on March 2, 2006, NOTICE IS HEREBY GIVEN of the intention of said Parish Council to amend the boundaries of Recreation District No. 10, St. Tammany Parish, Louisiana, to remove the following described area, comprising the boundaries of Parish Voting Precinct 307, from its jurisdictional limits and to add said area within Recreation District No. 1, to-wit:
