Honorable Council Members:

The Warranty Obligation in the amount of \$41,800 expires June 6, 2006 and is scheduled for review by the Parish Council at the May 2, 2006 meeting.

The developer was notified on February 17, 2006 by the Department of Engineering of the punch list items required and for his engineer to certify to this office at least (60) days prior to the expiration of the obligation, that the punch list has been completed.

This office has not received such notification. Therefore, this obligation must be extended for one (1) year or until the work is satisfactorily accomplished.

The following punch list items remain:

- 1. Roadway needs to be broomed for a meaningful inspection to be made;
- 2. Roadside ditches are silted up and holding water. They need to be re-graded to have positive flow
- 3. Check for need to replace blue reflectors.
