**AN ORDINANCE TO CORRECT THE ROAD INVENTORY TO INCLUDE 8<sup>TH</sup> STREET, 9<sup>TH</sup> STREET, SAM'S BRANCH ROAD, AND AN EXTENSION OF GOLDEN LANE. WARDS 2, 8 & 10, DISTRICTS 2 & 6**

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The St. Tammany Parish Selective Road Maintenance System Inventory is amended to include

1. 8<sup>TH</sup> Street and 9<sup>TH</sup> Street, both located north off of Pilot Street (R10F042), Ward 10, District 6;
2. Sam's Branch Road, located west off Highway 40/437, Ward 2, District 2; and
3. A 200 feet extension of Golden Lane (R08A006), Ward 8, District 6.

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.
