AN ORDINANCE TO CORRECT THE ROAD INVENTORY TO INCLUDE AN EXTENSION OF FOURTH STREET (R09D044); AND AN EXTENSION OF FIFTH STREET (R09D045). WARD 9, DISTRICT 14

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The St. Tammany Parish Selective Road Maintenance System Inventory is amended to include:

1. An approximately 405 feet extension of Fourth Street (R09D044), located south off Soldier Street (R09D043), Ward 9, District 14; and
2. An approximately 690 feet extension of Fifth Street (R09D045), located north off Sailor Street (R09D054), Ward 9, District 14

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.
