AN ORDINANCE TO CORRECT THE ROAD INVENTORY TO INCLUDE ROSALIE LANE; AND AN EXTENSION OF NORTH 9TH STREET (R08J124). WARD 8, DISTRICTS 9 & 14

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The St. Tammany Parish Selective Road Maintenance System Inventory is amended to include:

1. Rosalie Lane, located west off Highway 1091, Ward 8, District 9; and
2. An extension (approximately 425') of North 9th Street (R08J124), located south off Amos Road, Ward 8, District 14

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.
