ORDINANCE TO EXTEND FOR AN ADDITIONAL SIX (6) MONTHS THE MORATORIUM ON ISSUANCE OF BUILDING PERMITS FOR CONSTRUCTION OR PLACEMENT OF BUILDING STRUCTURES ON PROPERTIES WITHIN UNINCORPORATED ST. TAMMANY PARISH ABUTTING, IN WHOLE OR IN PART, PORTIONS OF TANTELLA RANCH ROAD AND HIGHWAY 1077 FROM HIGHWAY 190 TO THE PARISH LINE, AND WHICH PROPERTIES USE SAID ROADWAYS FOR PURPOSES OF INGRESS TO AND EGRESS FROM SAID PROPERTIES. (WARD 1, DISTRICT 1)

WHEREAS, per Ordinance C. S. No. 05-1071, a six (6) month moratorium was imposed on the issuance of permits for construction or placement of building structures on any properties within unincorporated St. Tammany Parish abutting, in whole or in part, Tantella Ranch Road and any properties abutting Highway 1077 from Highway 190 to the Parish line, and which properties use said roadways for ingress and egress. Thereafter, the Parish Council adopted subsequent ordinances, each extending the moratorium for an additional six month period; and

WHEREAS, a certain portion of the moratorium area was vacated by Council Resolution C-1896, adopted September 7, 2006, with the remaining effected area continuing to be subject to the restrictions imposed by the moratorium; and

WHEREAS, the moratorium is to protect and preserve the health, safety and property interests of residents from the potential hazards of a proliferation of driveways, adverse affects on traffic patterns on substandard roadways, and the adverse effects on natural hydrology and infrastructure needs of the surrounding areas by continued development of properties; and

WHEREAS, it is necessary to extend the moratorium in the remaining effected area to allow sufficient time for continued review of existing land use, drainage infrastructure, and traffic patterns and to formulate measures for future growth in order to protect residents in and near the area more fully described within this ordinance.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that it extends for an additional six (6) months the moratorium on the issuance of permits for construction or placement of building structures on properties within unincorporated St. Tammany Parish which abut, in whole or in part, a portion of Tantella Ranch Road and properties abutting, in whole or in part, a portion of Highway 1077 between Highway 190 and the parish line, less and except those areas removed from the moratorium area by Council Resolution C-1896, adopted September 07, 2006, Ward 1, District 1, described as follows and as more fully indicated on the vicinity map attached hereto:

- Area 1 From the intersection of the southernmost end of Northridge Drive and La. Highway 1077, proceed in a southerly direction on La. Highway 1077 to its intersection with McGee Road.
- Area 2 From the intersection of Jones Road and Tantella Ranch Road, proceed in a southerly direction on Tantella Ranch Road to its intersection with La. Highway 1077.

BE IT FURTHER ORDAINED that this Ordinance shall be effective immediately upon final adoption and remain in effect through April 5, 2007.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.
