ORDINANCE TO AMEND THE OPERATING AGREEMENT GOVERNING PROCEDURES FOR ANNEXATION AND RELATED GROWTH MANAGEMENT ISSUES BETWEEN THE PARISH OF ST. TAMMANY AND THE TOWN OF PEARL RIVER; AND TO PROVIDE FOR OTHER MATTERS IN CONNECTION THEREWITH.

WHEREAS, on March 26, 2003 the St. Tammany Parish Council adopted Ordinance C.S. 03-0643 authorizing the Parish President to enter in to an agreement to govern annexation and related growth management issues between Parish of St. Tammany and the Town of Pearl River; and

WHEREAS, the Parish of St. Tammany and the governing authority for the Town of Pearl River have entered into an operating agreement to govern procedures for annexation and related growth management issues as per said ordinance; and

WHEREAS, the Parish of St. Tammany and the governing authority for the Town of Pearl River have a desire to amend said agreement to expand the physical boundaries of annexation areas as per "Exhibit A"; and

WHEREAS, the Village Gutherie Subdivision, located immediately adjacent to recently annexed property is in need of centralized water and sewer services.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that upon satisfactory understanding relative to the Town of Pearl River assisting Parish Government in providing water and sewer services to Village Gutherie Subdivision, the operating agreement to govern procedures for annexation and related growth management issues between the Parish of St. Tammany and the Town of Pearl River is hereby amended and attached herein as Exhibit A.

BE IT FURTHER ORDAINED that the Parish President is authorized to sign said amendment and the amendment shall be filed in the conveyance records of the St. Tammany Parish Clerk of Court.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after final adoption.
