ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACCEPT THE ACT OF DEDICATION AND DONATION OF TWO PARCELS OF LAND AT GUSTE ISLAND ROAD A/K/A PORT LOUIS ROAD AND TO INCLUDE SAME INTO THE ROAD MAINTENANCE SYSTEM, NAMELY 0.089 ACRES & 0.092 ACRES IN SECTION 17, T7S, R10e. (AS SHOWN IN EXHIBIT "A" ATTACHED HERETO)

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that:

SECTION I: The Act of Dedication and Donation by Guste Island Holding Company, LLC for two parcels of land off Louisiana Hwy. 22, namely 0.089 acres and 0.92 acres in Section 17, T7S, R10E, is accepted, and same shall be incorporated into the St. Tammany Parish Selective Road Maintenance System Inventory.

SECTION II: The Parish President and/or C.A.O. is hereby authorized to execute any and all documents necessary in connection with said acceptance of said two parcels of land.

SECTION III: The Department of Public Works is directed to provide the appropriate maintenance.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

EFFECTIVE DATE: This ordinance shall become effective fifteen (15) days after adoption.
