The developer was notified on July 6, 2006 by the Department of Engineering of the punch list items required and for his engineer to certify to this office at least (60) sixty days prior to the expiration of the obligation, that the punch list has been completed.

This office has received such notification that the developer wishes to extend the warranty for one (1) year or until the work is satisfactorily accomplished.

### The following punch list items remain:

- 1. The roadway needs to be broomed for a meaningful inspection to be made;
- 2. Roadside swales are not functioning; causing standing water along the roadway;
- 3. Silt abatement measures are not being employed; silt is entering the flush grates and subsurface drainage;
- 4. Outfall culvert between Lots #22/23 is damaged and must be replaced;
- 5. Rip-rap splash pads and grating have not been installed at the end of the outfall culverts as stated by your engineer in his letter dated December 6, 2005;
- 6. Permanent street name signs are needed;
- 7. Permanent Traffic signs are needed.

### Honorable Council Members:

The Extended Warranty Obligation in the amount of \$28,700 expires November 5, 2006 and is scheduled for review by the Parish Council at the October 5, 2006 meeting.

The developer was notified on July 7, 2006 by the Department of Engineering of the punch list items required and for his engineer to certify to this office at least (60) sixty days prior to the expiration of the obligation, that the punch list has been completed. If not, the obligation will be automatically called.

This office has received such notification that the developer wishes to extend the Warranty. Therefore this obligation would normally be called. However, in accordance with Resolution Council Series No. C-1528, passed at the September 28, 2005 Special Parish Council Meeting regarding Hurricane Katrina, the Warranty Obligation will be extended for one (1) year from the expiration date shown.

The following Punch List items were submitted to the developer on July 7, 2006 and remain:

- 1. Roadside ditches are silted up and holding water. Ditches need to be re-graded to provide positive flow;
- Outfall ditches and detention ponds need to be checked for possible silt removal;
- Blue reflectors need replacing at some locations;
- 4. Medians do not contain fill material allowing silt to flow onto roadways. Curbs need to be constructed similar to entrance median;
- 5. Revised AS-BUILT drawing is needed showing ditch at rear of lots #22 & 23.

#### Honorable Council Members:

The Warranty Obligation in the amount of \$70,700 expires November 8, 2006 and is scheduled for review by the Parish Council at the October 5, 2006 meeting.

The developer was notified on July 14, 2006 by the Department of Engineering of the punch list items required and for his engineer to certify to this office at lease 60 days prior to the expiration of the obligation, that the punch list has been completed.

This office has not received such notification. Therefore, this obligation must be extended for one (1) year or until the work is satisfactorily accomplished.

The following punch list items remain:

- 1. The concrete roadway needs to be cleaned of all silt so that a meaningful inspection can be made;
- 2. The roadside swales are not functioning in many locations due to the aggregate access roads for FEMA trailers crossing swales and blocking the surface grates. We have been informed by Textron Company's site management that your lease with them will expire October 26, 2006. These temporary access roads need to be removed and the swales restored after the FEMA trailers are removed from the site;
- 3. The Parish will be eventually responsible for the maintenance of the detention ponds. Therefore, all weeds, grass, & temporary fencing must be removed so that the condition of the ponds slopes can be inspected for acceptability.
- 4. All signange and blue reflectors need to be restored.

We await your engineer's notification in a timely manner.

- 2. Roadside swales have standing water and need to be re-graded to provide positive flow.
- 3. Silt abatement is not being employed and is causing silt to enter flush grates and subsurface drainage; the developer's engineer must certify that subsurface is free of silt;
- Replace street name signs as required;
- 5. Replace traffic signs as required;
- 6. Replace blue reflectors as required.
