WHEREAS, the TOWN OF PEARL RIVER is contemplating annexation of 13.52 & 2.426 acres of land more or less, owned by James Fleming, and located at 40257 HWY 11, PEARL RIVER, LA., SECT 31, T-7-S, R-15-E 1ST PARCEL 13.52 ACRES

2ND PARCEL 2.426 ACRES, Ward 8, District 6 (see attachments for complete description); and

WHEREAS, the proposed annexation is not consistent with the Annexation Agreement entered into by the TOWN OF PEARL RIVER and St. Tammany Parish effective April 1, 2003; and

WHEREAS, the property requires rezoning from Parish Rural District to TOWN OF PEARL RIVER R-1 RURAL District which is not an intensification of zoning; and

WHEREAS, the property is not developed and the proposed annexation would not result in a split of the sales tax revenues, all sales tax revenue accrues to the Parish.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES to Concur/Not Concur with the TOWN OF PEARL RIVER annexation and rezoning of 13.52 & 2.426 acres of land more or less, located at 40257 Hwy 11, Pearl River, La., Sect 31, T-7-S, R-15-E

1st parcel 13.52 acres, 2nd parcel 2.426 acres, from Parish Rural District to TOWN OF PEARL RIVER R-1 RURAL District contrary to with the April 1, 2003 Annexation Agreement between the Parish and the TOWN OF PEARL RIVER.

BE IT FURTHER RESOLVED that should this property be annexed, the St. Tammany Parish Council requires that the TOWN OF PEARL RIVER review development proposals utilizing the applicable Parish Drainage Model and compliance with Parish Drainage Regulations.

BE IT FURTHER RESOLVED that the St. Tammany Parish Council requires that the TOWN OF PEARL RIVER require a Traffic Impact Analysis be performed and that the Parish Department of Engineering be consulted on the traffic and access impacts of any proposed development.

As agreed with the Parish Sales Tax Split Agreement the Town is asking the Parish's consent to annex this property.


